## Budget Vote May 17

### Noon to 9 p.m. General Election Polling Sites

While almost three-quarters of the school district's budget revenue comes from State aid, and the proposed budget has NO INCREASE to the local tax levy, it is nonetheless important that residents take the time to cast a vote on the proposed budget.

Bear in mind that residents vote on what the school district can spend; that is to say, the amount voters approve for spending is all the District can spend. Like all school districts and many not-for-profits, the bulk of the expenditures are spent for salaries and benefits. That makes sense, since the "product" the District produces is the transfer of knowledge from teachers to students.

Following are the highlights of the proposed 2016-2017 school district budget, on which residents will vote between noon and 9 p.m. on Tuesday, May 17.

Please note: voting sites are the same as general election polling sites.

- Total State Aid revenue estimates show a net increase of \$3,548,992, broken down as follows:

The GAP elimination adjustment (GEA) in State Aid is projected to be eliminated. This would increase District aid by \$27,562.

- An increase of \$1,905,000 in Building Aid is the largest portion of the projected increase. This money is to be used for our recently completed capital projects: Inventing Tomorrow. District expense-based aids also show a net increase for 2016 – 2017.

- Foundation Aid: This is the largest portion of State Aid received by school districts and has just recently begun to rise. It is projected to increase by \$1,323,470.

---The Governor has added a new category called Community Schools Aid for high needs schools, such as ours.


--- The proposed District budget includes the limited use of appropriated fund balance. Any surplus

generation in 2015-2016 will be saved as unreserved fund balance. The proposed budget calls for an exit from the Teachers' Retirement System Balancing Plan, included as a reduction of expenditures. It includes NO increase to the tax levy.

The total amount of the proposed budget on which residents will vote is \$137,055,127, or 2.58% greater than the current year budget. The tax levy remains unchanged at \$25,828,989.

## Budget Vote: Stand and be Counted

In preparing the recommended budget for the upcoming school year, I was conscious of the fact that this is my last time guiding the budget process, and I was sure of one thing: it is one of the few aspects of my job I won't miss!

In the years since I became an employee of the Niagara Falls City School District, many needs have changed in the community, and so in the school district.

Today's students often come to us from a variety of families and homes. Too many are poor. Some have not a single book at home. Others never hear that school is important or that learning is a gift as well as a responsibility. Still others need enriched and enhanced learning to meet academic growth.

Money won't remediate all of these challenges, but make no mistake, it does help. Greater funding would for more resources, not only in our District, but nation-wide; things like more afterschool programs, counselors, more teachers and support personnel. Add to that list the maintenance of 13 campuses or work sites. All of these needs must be met while still maintaining our fiduciary responsibilities to you, the taxpayers.

But for this year, while I cannot report that the District is fully funded, I am happy that the District did receive a net increase enabled me to recommend to in State Aid of \$2,100,000. That the Board, and the Board to

adopt, a budget with no increase to the tax levy to present to you. That is certainly good news. Please vote on the budget so that we can continue our work with children.

In addition to casting a vote on the budget, the other major thing you can do if you are a parent or legal guardian of a student in the District, is to be sure at the beginning of each school year to fill out and turn in the Free and Reduced Meal Application that the schools will provide to you. The financial information gathered on this form allows the District to apply for grants, which are very helpful. It also allows us to qualify for the Community Eligibility Option (CEO), based on the relative poverty of the community as a whole. Through CEO, we can provide free breakfast and lunch to all our students. That is a money- and time-saving option for parents, and ensures every student can enter the classroom having eaten a satisfying and nutritious meal, and, therefore, better able to pay attention and learn.

Our financial journey has always been a challenging one, but our priority has always been the same: Learning For All ... Whatever It Takes. Please continue to partner with the school district as we travel this road together...on behalf of all of our children. Please cast your vote May 17 between noon and 9 p.m. at general election polling sites.

## Opt-In to District Text Messaging!

We are adding text messaging capability to SchoolMessenger, the system we use now for automated phone calls and emails. The system will be configured to send text messages to cell phone numbers whose recipients have agreed to receive them. Over the next weeks, we will be encouraging stakeholders to confirm we have accurate phone numbers and encourage them to participate.

There are only two requirements for a recipient to receive messages from you via SMS text: the recipient's wireless number imported into SchoolMessenger and "Opt-In Confirmation" from the recipient's wireless device. These requirements address any concerns related to the accuracy of the database and costs associated with receiving text messages.

Recipients can easily opt-in by simply sending "Y" (or "Yes"), via text message, to our SchoolMessenger Short Code number 67587. We will be inviting recipients to do this over the next several weeks and continue throughout the year.

The wireless number(s) must be in the SchoolMessenger database associated with a student or staff ID number; these numbers are updated regularly.

If a recipient's number SMS Text number is changed, or a new number added, in our student information system database, the new number will automatically be sent an Opt-In message.

### FAQs

#### How do recipients "Opt-In" to receive text messages?

1. Confirm the text device number(s) is on file with the District.
2. Text "Y" to 67587 from each wireless device you wish to

receive texts on. Note: Depending on the data synchronization configuration, it may take 24 hours or more for numbers to be updated from the District's database.

#### How do recipients opt-out of receiving text messages?

Recipients not wishing to receive text messages to a particular number can simply do one of the following:

1. Don't opt-in and don't reply to the opt-in invitation message.
2. Text "STOP" to 67587 at any time.
3. Request that your organizations SchoolMessenger Communicate system administrator add the number to the account's phone number block list.

#### Can the text messages come from a district phone number, instead of the short code?

No. Short codes are the industry standard, and the only fast and reliable way to deliver mass text notifications.

#### I received a text message that says it's from SchoolMessenger? What does it mean?

If it was from 67587, that was most likely the Opt-In Invitation message sent by SchoolMessenger. To continue receiving informational text messages from the school(s) reply with "Y".

If you do not reply, you won't receive any future texts from our schools.

#### I "Opted-In", but I'm not receiving texts?

Ensure that the District has your correct device number in the database (Student Information System or HR System), and that it is located in the SMS phone field(s) that are synchronized with SchoolMessenger. It may take 24 hours for a number to become active after being changed or added to

the District's system. Send a text with "Y", from that specific device, to 67587. You should receive an opt-in confirmation message from the service. If you want to receive texts on multiple devices, each device number must complete the Opt-In process.

#### How do I know if it worked?

After you text one of the key words to the short code the system will ALWAYS respond back with one of three messages:

**Opt-in Response:** You're registered for SchoolMessenger notifications. Reply STOP to cancel, HELP for help. Msg&data rates may apply. msg freq varies.

**Opt-out Response:** You're unsubscribed from SchoolMessenger. No more msgs will be sent. Reply Y to re-subscribe, HELP for help. Msg&data rates may apply.

**schoolmessenger.com/txt**  
**Help or Unknown Key Word Response:** SchoolMessenger notification service: Reply Y to subscribe or STOP to cancel. Msg&data rates may apply. Msg freq varies. Visit [schoolmessenger.com/txt](http://schoolmessenger.com/txt) for info  
 Any other response – or no response: indicates the recipient should contact their wireless device provider to have SMS messaging/premium content enabled (see below for more details).

What does it mean if I texted "Y" or "yes" and I received some sort of error message back?

If you receive what appears to be an error message, similar to one of the following, it most likely means that short code text messaging is not enabled on your wireless subscription plan:

- Service access denied
- Message failed
- Shortcode may have expired or shortcode texting may be blocked on your account
- Does not participate



These replies DO NOT indicate that the wireless provider can't receive messages from SchoolMessenger. Rather, they are an indication that the specific mobile device does not have short code SMS texting enabled for that number (this is sometimes disabled by default on company provided cell phones).

To address this, contact your wireless provider. Note: Providers sometimes use various names for this type of texting service (e.g. short code, SMS, premium, etc.). If you simply ask about text messaging, your carrier may assume you are referring to person-to-person. Therefore be very clear to refer to "short code" text messages. Most TV programs which have a voting component use short code SMS messaging (e.g. American Idol, Dancing with the Stars). Using an example such as this can be helpful in clarifying the type of texting service you want to enable.

#### Will I be charged for the text messages that I receive from SchoolMessenger?

SchoolMessenger does not charge recipients for the text messages that they receive or send to the short code; however, wireless providers may charge for individual text messages, depending on the plan associated with the wireless device. Please consult your carrier if you are uncertain.

### Johnny Destino



Over the past several years, no one in Niagara Falls has fought harder to promote and protect public education and provide alternative pathways to graduation than Johnny Destino.

The efforts of Mr. Restaino have been recognized in our community as a recipient of the National Family Advocacy Award, Business Association Leadership Award and the Niagara Falls School District Golden Apple Award.

Mr. Restaino believes in providing the best in academic and vocational educational opportunities to students. As a Board member, Mr. Restaino helped to oversee the Inventing Tomorrow capital projects, which provided advanced Science, Technology, Engineering, and Math classrooms to every student; he has supported budgets that do not increase the tax levy; and he has supported teachers and students.

### Carmelette Rotella



Carmelette Rotella retired after more than 30 years of service as a teacher and guidance counselor in the Niagara Falls School District. Born and raised in Niagara Falls, Mrs. Rotella earned a BA in History from the University at Buffalo and a Master's in Education from Niagara University. She also is a graduate of Leadership Niagara. In 2001, Mrs. Rotella was the recipient of the Western New York Leadership Award from the NYS

United Teachers and the Niagara Falls Teachers Distinguished Service Award.

She is married to Richard, a local attorney. Their two daughters, Rachel and Marisa, are graduates of the Niagara Falls public school system.

She was an active participant in the Teachers Union serving as president, vice-president and as an executive council member. She also served on the Teacher Center Resource Board including a year as chairperson helping set policy and staff development programs for District employees. Mrs. Rotella served as the Orleans-Niagara BOCES representative, where her experience as a school counselor at Trott Vocational High School, gave her firsthand knowledge of vocational education. She has worked hard to assure that students have the opportunity to pursue career and technical training so that, to date, more than 321 school district students attend such programming at the Orleans-Niagara Technical Training Center. She participated in community service on behalf of organizations including the Niagara Falls Housing Authority where she served as commissioner and chairperson. In these capacities, she has lobbied local, State, and federal officials on issues of concern and funding. Mrs. Rotella has been a lifelong advocate for children and their families as can be seen in her work.

During her tenure on the Niagara Falls Board of Education, student test scores have improved, graduation rates have increased, a \$116.7 million capital project improvement plan was created that enabled the building of Niagara Street School, improved technology and science labs(STEM), infrastructure improvements in all our schools, and the building of new athletic complexes - AT NO COST TO THE TAXPAYERS. This was accomplished using local labor and businesses. Personally, Mrs. Rotella has participated in Board planning concerning construction, financing, program, personnel, and technology. She believes she has been a conscientious, committed member of the Board of Education and is prepared to ask for your support to continue to serve our students, staff, and community. ## Pre-Kindergarten

### Age 4

The District offers Universal Pre-Kindergarten for all residents who will be 4-years-of-age on or before December 1, 2016.

In Pre-Kindergarten, expect your child to have a curriculum and lessons just like every other grade. While fun is on the agenda, there is plenty of learning, too.

Early literacy skills, following directions, basic math, social skills and so much more are taught to our youngest scholars. Students are also given a healthy lunch each day.

New York State Pre-Kindergarten Standards

Communication, Language, and Literacy

- Students will be able to demonstrate that he/she understands what he/she observes.
- With prompting and support, ask and answer questions about details in a text.
- With prompting and support, actively engage in group reading activities with purpose and understanding.
- With prompting and support, use a combination of drawing, dictating, or writing to compose informative/explanatory texts in which they name what they are writing about and apply some information about the topic.

Mathematics

- Demonstrate an understanding of addition and subtraction by using objects, fingers, and responding to practical situations (e.g., if we have 3 apples and we add 2 more, how many do we have?).
- Duplicate and extend (e.g., what comes next?) simple patterns using concrete objects.
- Identify measurable attributes of objects, such as length, and weight. Describe them using correct vocabulary. (E.g. small, big, short, tall, empty, full, heavy, and light.)

Science

- Describe and compare the effects of common forces (pushes and pulls) on objects, such as those caused by gravity, magnetism, and mechanical forces.

Social Studies

- Recognize the roles/contributions of community workers as they produce goods/services that people need.

Social and Emotional Development

- Develop positive relationships with their peers.
- Demonstrate pro-social problem solving skills in social interactions.

UPK is held at every elementary school and at the Doris W. Jones Family Resource Building, the LaSalle Early Education Center at St. John de LaSalle, and the HANCI -administered site at Cataract Elementary School.

### Age 3

Thanks to a State grant, it also offers a limited number of 3-year-old students placements in Pre-Kindergarten 3 (PK3). The District is one of only 26 Districts to have secured this grant. Students who qualify for free meals based on the Free & Reduced Meal application will receive priority placement; a lottery will be held. Once slots are filled, a waiting list will be created.

Basic Facts About Pre-kindergarten 3 (PK3)

The program will address early school readiness skills in an effort to better prepare children for the District's Universal Pre-K/4year old program.

Children who have turned 3 years of age, on or before the enrolling year are eligible to apply to attend.

The program will be held at Harry F. Abate Elementary School.

Days and hours for the program are as follows:

- Monday - 9:30 AM – 2:30 PM
- Tuesday – 9:30 AM – 1:30 PM
- Wednesday – 9:30 AM – 2: 30 PM
- Thursday – 9:30 AM – 2:30 PM
- Friday – 9:30 AM – 2:30 PM

The Pre-K 3 school day STARTS AFTER and ENDS BEFORE the school day for students in grades Kindergarten through 6, so they enter and leave in the calmest of environments. The school day unfolds entirely in the Pre-K 3 classroom.

The program will include family events and informational workshops; students enrolled in PreK3 will automatically have a spot reserved at the home school for Universal Pre-Kindergarten (UPK)\* at age 4!

**ALL students attending the public schools in the Niagara Falls City School District are eligible to receive a healthy breakfast AND lunch at school at NO CHARGE.**

**There is NO TRANSPORTATION to UPK or PK3 classes. Parents or guardians are responsible to transport students to and from school.**

## A Visit to PK3 Classrooms

Thanks to the District securing one of only 26 NYS grants State-wide, it now offers Pre-Kindergarten 3 to 40 three-year-old students. Two classrooms, each containing a teacher and two assistants at Abate School, welcome 20 students each 24 hours a week. Preference is given to students from low-income households; the District hopes to expand the program next year. Those students who are placed in PK3 (selected by lottery) are guaranteed a placement in Universal Pre-Kindergarten for four-year-olds at their home schools.

"Purposeful play" is the mantra in these classrooms, where the school day STARTS AFTER and ENDS BEFORE the school day for students in grades Kindergarten through 6, so the youngest students enter and leave in the calmest of environments. The school day unfolds entirely within the Pre-K 3 classroom. The program also includes family events and workshops.

Teachers Trish Hennegan and Angela Martin are enjoying circle time, dance, and singing while teaching socialization and the fundamentals of the alphabet and numbers.

There are Five Early Childhood Domains that serve as the umbrella for the early childhood curriculum. These domains make-up the NYS Early Learning Guidelines.

These domains are:

Domain I - Physical Well-Being, Health, and Motor Development  
Domain II - Social and Emotional Development

Domain III - Approaches to Learning

Domain IV - Cognition and General Knowledge

Domain V - Language, Communication, and Literacy

Each PreK3 student will benefit from screenings that will take place before their classroom experience begins and again at the end of the school year. This will measure individual student growth in all five domains, so you can see your child's progress!

Fun is the order of every day, though, as children learn and make friends in a classroom just right for them.

## Safety Corner: Bike Weather

Time to get out your bike and hit the trails! Just a few safety reminders:

- Always wear a helmet! Children under 14 MUST wear a helmet, however, it is recommended that everyone wear a helmet when riding a bike.
- Ride on the Right side of the street- WITH traffic.
- Obey traffic signs and lights when riding on City streets.
- Use hand signals to tell cars and fellow cyclists where you are going.
- Be visible to cars and pedestrians. If you bike at night, use safety lights and wear light colors or reflective clothing.
- Carry water with you on long trips! Stay hydrated in the heat!
- Off on a long adventure? Make an energy-filled snack like the following one:



Energy Snack Mix

3 cups of whole-grain cereal (Cheerios, Wheaties, Chex...)  
 1 cup dried fruit (raisins, banana, cranberries, mango, pineapple, apricots...)  
 ½ cup of nuts (peanuts, sunflower seeds, almonds...)  
 Mix together in bowl.  
 Serving size: ½ cup

Also...

The Centers for Disease Control reminds parents that a few serious sunburns can increase your child's risk of skin cancer later in life. It recommends planning outdoor activities before or after mid-day, or at least seeking shade under a tree, an umbrella, or a pop-up tent.

Also, keep children covered up with long-sleeved shirts and long pants from tightly woven fabric. Dry, dark colored clothes darker colors may offer more protection than lighter colors. Don't forget a hat.

Children should wear sunglasses to protect eyes from UV rays, which can lead to cataracts later in life.

Apply sunscreen with at least SPF 15 and UVA and UVB protection every time your child goes outside.
