On the Basis of Sex

On the Basis of Sex is a biopic based on the life of Supreme Court Justice Ruth Bader Ginsburg. The movie focuses on the early part of her life, emphasizing her law school years and her first gender discrimination lawsuit. The movie, which writer Daniel Stiepleman explains is about "a young lawyer who is trying to find her voice," is perfect for law students.

Loving

The 2016 film, directed by Jeff Nichols, is based on the lives of Richard and Mildred Loving, whose arrest for interracial marriage in Virginia in 1958 led to a legal battle that made its way to the Supreme Court of the United States. The movie, which garnered rave reviews, will provide a satisfying background for when you inevitably read Loving v. Virginia in your constitutional law class.

Marshall

Starring Chadwick Boseman and Kate Hudson, Marshall is based on an early trial in the long career of Supreme Court Justice Thurgood Marshall. The movie follows Thurgood as he travels to Connecticut to defend a black chauffeur charged with sexual assault and attempted murder of his white employer. The case led to Marshall's creation of the NAACP legal defense fund.

Michael Clayton

While most legal films focus on the heroics of a lawyer's pursuit of justice, Michael Clayton takes a slightly different approach by focusing on a fixer brought in by a law firm to clean things up after a lawyer has a breakdown while representing a chemical company he knows is guilty.
